Discovery Awards is an international platform that recognizes and showcases the stories of grassroots innovators worldwide!

The idea originated from Project Discovery in India, an initiative to collect, catalogue, and disseminate assistive solutions nationwide. Recognizing the value it places on grassroots creators, the international community joined the movement. In 2022, Zero Project, an organization working towards zero barriers worldwide, endorsed Discovery Awards. Starting from the Zero Project conference in Vienna in 2023, two grassroots innovators attended the event to present their solutions and receive awards.

Following the "one country, one partner" model, we are seeking various country partners to carry forward this program in their respective nations. During 2022-2023, 10 countries signed up for Discovery Awards. This year, 25 countries have already joined this impactful movement. Discovery Awards has garnered recognition worldwide for celebrating grassroots innovators whose solutions have the potential to positively impact a large number of people with disabilities. A Unique Partnership for Training and Employment

The WORTH Trust in Vellore is an organization dedicated to employment, rehabilitation, education, training, and differently-abled of individuals. The empowerment Rehabilitation Institute at Christian Medical College (CMC) was founded by Dr. Mary Verghese, a wheelchair user due to spinal cord injury, and offers comprehensive rehabilitation for persons with spinal cord injuries and other severe disabilities. Beyond medical care, they focus on social and vocational opportunities to transform individuals into dynamic and resourceful members of the community.

Two success stories at WORTH Trust, Samu and Sakthivel, showcase the positive impact of this unique partnership in empowering individuals with SCI to lead meaningful lives through gainful employment.

Samu was diagnosed with Meningiomas during childhood and underwent multiple surgeries leading to the loss of sensation in his spinal cord. In 2009, he began rehabilitation at Christian Medical College & Hospital (CMC) Vellore. Trained for independence by the Infection Control Committee, Samu spent three months in rehabilitation in 2015.



Thanks to the support of social workers Mr. Ilango, Dr. Guru, and Mr. Magesh from CMC Rehab, Samu gained confidence and received training in tailoring at the Mary Verghese Trust. He worked at various places like Myntra, a clothing store in Tiruvannamalai, and PVR Cinemas in Vellore. In 2022, Dr. Guru, Mr. Magesh, and Mr. Kevin introduced Samu to WORTH Trust.

Since joining WORTH Braillers in June 2022, Samu works as a technician, assembling Perkins Braillers and White Canes. Today, he looks forward to a bright future for the organization and its efforts to provide training and employment opportunities for more persons with SCI individuals and persons with other disability.

Sakthivel, born in Palluthur Village, K. Kuppam, Vellore District, completed his Electronic Trade in 2013. An accident in 2014 left him with a Spinal Cord making Injury, dependent on his family and friends. Undergoing treatment at CMC Rehab, he found support from Dr. Guru and Mr. Magesh, who encouraged independence and passion for sports.



He participated in and received medals and trophies at the state level in basketball, cricket, badminton and wheelchair marathon. This amped up his confidence to pursue opportunities to get employed.
